<sup>\*</sup>A "distance education course" is one in which faculty and students are physically separated in place or time and in which at least two-thirds of the instruction is provided via some form of mediated delivery system (i.e., 10 or more hours of instruction per credit hour are delivered via audio or video recording, live interactive video, CD-ROM, the internet, etc.). For the purposes of this report, hours reported in the "Distance Ed" category also include courses with a combined delivery method, in which at least half of the delivery method is delivered over a distance, but the student is required to periodically attend on-campus or inclassroom sessions.
