Barton Refund/Withdrawal Information

The last day to drop a Fall 2013 class for a refund is Friday, August 30th, 2013.

Students are responsible for communicating that they would like to drop a class and completing a Course Drop Form before this deadline. Depending on the form of payment used during enrollment in the class, there are various methods for how a refund will be returned. If a credit or debit card is used, the payment will be electronically returned to the card. Other methods of payment will be returned via a check sent to the address listed on the student enrollment form.

The final day to withdraw from a class with a "W" for a grade is Friday, November 1st, 2013.

SENATE BILL 155

The Kansas Senate passed Senate Bill 155 in May 2012. This bill authorizes the state of Kansas to pay tuition charges for any tiered Career Technical Courses. Therefore, courses designed as Senate Bill 155-eligible will be available to high school students at no cost except textbook and program fees (if applicable). This applies to face-to-face and online Career Technical Courses.

1. *PRE-REQUISITE INFORMATION

Certified Nurse Aide

ASSET Reading Skills score of at least 35 or ACT Reading score of at least 14 or Accuplacer reading score of 54 or a Compass Reading Skills score of at least 58. English Composition I with a "C" or better will also be accepted. Students must also have completed CNA enrollment packet, made payment and TB Skin Test must be submitted prior to class's start date, or students may not be eligible to take the course.

English Composition I

ASSET Writing Skills score of at least 40 or ACT English score of at least 17 or Accuplacer Writing Skills score of at least 69 or Compass Writing Skills score of at least 55 **and** ASSET Reading Skills score of at least 40 or ACT Reading score of at least 18 or Accuplacer Reading Skills score of at least 69 or Compass Reading Skills score of at least 75.

Trigonometry

ASSET Reading Skills score of at least 40 or ACT Reading score of at least 18 or Accuplacer Reading Skills score of at least 69 or Compass Reading Skills score of at least 75 **and** MATH1828 College Algebra with a grade of C or better or ASSET College Algebra score of at least 38 or ACT Mathscore of at least 26 or Accuplacer College Level Math scores of at least 86.

Intermediate Algebra

ASSET Reading Skills score of at least 40 or ACT Reading score of at least 18 or Accuplacer Reading Skills score of at least 69 or Compass Reading Skills score of at least 75 and ASSET Elementary Algebra score of at least 39 or ACT Math score of at least 21 or Accuplacer College Level Math score of at least 1 or Compass Algebra score of at least 41.

Anatomy & Physiology

ASSET Reading Skills score of at least 40 or ACT Reading score of at least 18 or Accuplacer Reading Skills score of at least 69 or Compass Reading Skills score of at least 75 and an ASSET Writing score of at least 40 or ACT English score of 17 and ASSET Elementary Algebra score of at least 39 or an ACT Math score of at least 21.

All Barton Community College classes require a minimum ASSET Reading scale score of 40 or ACT Reading score of 18.

ENROLLMENT TO BE HELD: Wednesday, August 21st between 8:00 am and 10:00 am

- Students will need to know their Social Security Number or Barton ID to complete enrollment forms.
- Students are responsible for purchasing, renting, or borrowing their own textbooks. A Barton representative will have textbook information/order forms at enrollment

Final day to enroll/pay for classes: August 28th. No Exceptions.

PAYMENT OPTIONS:

- Pay in-person at enrollment via **Cash, Check, Credit Card, or Money Order.**
- Pay online via Credit Card or NBS Payment Plan.



HERE'S HOW:

- Notify the Barton representative at enrollment of how you plan to pay the tuition and fees for your class(es).
- Visit www.bartonccc.edu.
- Click the paw print in the top right-hand corner of the home page. Click PAWS on the next page.
- Enter Barton ID number and PIN. Use Lookup ID if you don't know your Barton ID. Read the directions for PIN.
- **To pay in full**, select **Pay Online** and choose the Fall 2013 semester.
- **To sign up for the payment plan**, select **NBS Payment Plan** and follow the prompts to set it up.
- Automatic bank payment (ACH)
- There is a \$30 per semester non-refundable fee for participating in the payment plan.
- Credit/Debit card payments will be processed on the 5th of each month until the balance is paid in full.

Please note, there is no way to make partial payments without signing up for the payment plan.

Boost Scholarship: Students on free and/or reduced lunch are eligible for the Boost. For qualifying students, Boost will cover tuition and fees for up to six credit hours of coursework per semester during an academic year (Fall, Spring, & Summer). Student will be held responsible for charges on above six credit hours. Boost does not apply to program fees associated with Senate Bill 155.
