
Center of the Ellsworth Correctional Facility.



Over 140 inmates were recognized for completing the necessary course work to receive Kansas High School Diplomas, 18 & 32-hour recognition awards, as well as Certificates in Introductory Craft Skills, OSLHA 10 Safety, Manufacturing Skills, Welding, Certiport IC3 Digital Literacy, Microsoft Word and Work Ready Certificates.

The Barton Community College Foundation was proud to present 11 young men with scholarships to continue their education through the BASICS (Building Academic Skills in Correctional Settings) Program. These scholarships were made possible through the generosity of donors whose vision and foresight appreciate the value of educating these students so they will have the employable skills necessary to return to our communities and join their families as contributing members of society.

The Barton Community College Foundation is the recipient of a grant awarded by the Dorothy M. Morrison Foundation. This grant will commit \$100,000 to be held in an unrestricted account with the Barton Community College Foundation. The structure of the account will allow future donations to be added to the fund. These funds shall not be designated for any particular campus project; however, as needs arise, the Barton Community College Foundation shall make written application to the Dorothy M. Morrison Foundation for the approval of the use of these funds. The Morrison Foundation shall be actively involved in determining how the funds are spent. The Dorothy M. Morrison Foundation will evaluate each project proposal according to its grant application guidelines and determine if it fits within the philosophy, purpose and priorities of the Morrison Foundation.

Sister Mary Ann Klein Endowment Funds CNA/CMA Scholarships

The Barton Community College Foundation received a grant from the Sister Mary Ann Klein Nursing Endowment established at the Golden Belt Community Foundation to provide scholarships for CNA/CMA students at Barton.

The endowment was established to provide

funding/support for the recruitment, retention, and training of health professionals and health educators, including but not limited to, scholarships, equipment, continuing education, and incentives, with a preference for programs that are offered through local agencies, community colleges, and medical facilities.





When asked if such funds were needed at this time and would be beneficial to the nursing program, Sara Hoff, Nursing Remediation Adult Health Care Program Coordinator, stated "There is a huge need for funding of CNA/CMA classes. Each of these are 5.0 credit hour

courses and federal financial aid is not available. This is one of the first things I tell students wanting to take the course so they can look into some of the options we have for funding or to start saving." Students will apply through the Barton Foundation to receive this scholarship assistance.
