Understanding the Kansas Documents Classification System

The Kansas Documents (KSDOC) classification system is used by the Barton Library and the State of Kansas to arrange government publications. Originally developed by the State Library of Kansas and Emporia State University's William Allen White Library, the KSDOC system groups together documents from particular state agencies and their subordinate bureaus and divisions.

The Barton Library's collection includes the twenty-four serials and monographic series deemed by the State Library to be core Kansas documents plus several others chosen for their relevance to the College's curriculum.

The KSDOC classification system is designed specifically for Kansas government documents while the United States government uses a similar classification system for official federal publications. See <u>Understanding the Superintendent of Documents Classification System</u> for more details.

Anatomy of a Kansas Documents call number

Publication title: Opinions of the Attorney General, Volume 6, 1973: Selected and edited opinions of Robert C. Londerholm, Attorney General and Kent Frizzell, Attorney General, written during the period from January 1, 1968 to January 11, 1971, inclusive.

Publishing agency: Kansas Office of the Attorney General

Call number: J 1.6:1968-1970

KSDOC call numbers are divided into two parts that combine to make a complete number.

First Part

• The first part begins with one to three letters that designate the issuing agency.

- The letters are based on key words in the agency's name.
 - See Appendix # 1 for a classification list of state agencies and their corresponding letters.
- Subdivisions are designated by one to two numbers.
 - The number 1 is used for the issuing agency and the office of the elected or appointed department administrator.
 - Beginning with 2, numbers designate subordinate offices within the parent organization.
- The first part ends before the period.

Second Part

- The second part of the classification number begins with the period.
 - One or two numerals indicate the format of the document.
 - See **Appendix** #2 for a listing of category classes.
 - Following the colon is a designation for the individual publication, such as a year number, a Cutter number, a volume and issue number, or another identifier.
